Dear Christian Friend,

Every morning, Haya—who is in her 80s—makes her way out of her little apartment in Israel and heads down a cracked asphalt path.

She walks slowly and carefully down a route she has painstakingly memorized. Sometimes she falls—but she gets up, dusts herself off, and continues on her way.

You see, Haya is elderly, blind, destitute, and struggling to survive on her own. She receives a meager monthly pension, but there's never enough money to buy adequate food.

My name is Yechiel Eckstein. I'm an orthodox rabbi who's been working with hundreds of thousands of Christians across America to help rescue Jews and fulfill biblical prophecy. Since the walls of communism fell in 1990, the *International Fellowship of Christians and Jews* has helped over 725,000 Jews escape oppression and persecution and flown them to freedom in Israel.

I'll tell the elderly Jews we serve at our soup kitchens in Israel that American Christians like you made these meals possible.
