Captioned individual, who you advised was born March 7, 1908, at New York, New York, was the subject of a selective service investigation in 1944 and 1945, when it was alleged he had illegally obtained an occupational deferment. Prosecution was declined by the U.S. Attorney in this matter in view of Feinberg's age and the probability that he would have been legitimately deferred because of his age and family.

The central files of the FBI, including the records of the Identification Division, contain no additional pertinent information concerning the captioned individual based upon background information submitted in connection with this name check request. (100-390666)
