Dear Gottlieb:

Below is the usual monthly statement of the situation on funds between us. I know that there is a dispute concerning the basic budget. The accounting below does not include any adjustment since my letter of September 11, 1958, at which time the understanding was that the basic budget was set at \$500,000 per annum and the Youth budget at \$86,500, making a total of \$586,500 and a monthly allocation of \$48,875.00. If discussions now result in any change in these basic figures I shall send you a supplementary note confirming such changes and making the necessary adjustment.
