Dear Gottlieb:

Below is the accounting due March 1, 1958. I need not add that the total still comes high. You can see for yourself, however, that half of it is the result of a large balance still due to us and three items that are not regularly part of our budgeted expenses. Our own actual monthly allocation is considerably less than half the total. I wish that we could get our payments down to the level of just this regular monthly allocation.
