Dear Mr. Smith:

This is a follow-up response to your April 23, 2013, Freedom of Information Act (FOIA) request for Federal Bureau of Investigation (FBI) records in the custody of the National Archives and Records Administration (NARA). This response addresses only the six remaining files listed in our May 5, 2015, response to you that required processing under NARA case number **RD 40132**.

As reviewed under the terms of the Freedom of Information Act (5 USC 552), there are no restrictions on access to the following files, and they are now open and available for research use:

100-DE-20297: (Record Entry ID: HS1-89646273 [P 171]; Classification 100 (Domestic Security), Field Office Case Files: Detroit, Michigan; Box 560; 7 pages; Location: 131E/902/25/6)

We completed a line-by-line review of the remaining files and released information to the greatest extent possible. Information exempted from disclosure under the terms of the Freedom of Information Act (5 USC 552) has been redacted. The redactions have been applied to protect the identities of named informants or confidential sources per 5 USC 552 (b)(7)(D); to protect procedures and techniques for law enforcement investigations per 5 USC 552 (b)(7)(E); or to protect information exempted from disclosure by statute per 5 USC 552 (b)(3). The specific statute cited is **50 USC 3024(i)(1)**, which pertains to intelligence sources and methods protected by the Director of National Intelligence. The following files have been released in redacted form:

100-CG-1816: (Record Entry ID: HS1-100952641 [P 166]; Classification 100 (Domestic Security), Field Office Case Files: Chicago, Illinois; Box 63; 157 pages total with 18 pages containing redactions under either (b)(7)(D) or (b)(7)(E), and 7 pages withheld in full under (b)(7)(D), (b)(7)(E), and (b)(3)-50 USC 3024 (i)(1); Location: 490/49/35/4)

You have the right to appeal our decision to restrict access, either in whole or in part, to any document over which this agency has release authority, within 60 calendar days of receipt of this letter. Appeals can either be submitted in writing and addressed to the Deputy Archivist of the United States, National Archives and Records Administration, 8601 Adelphi Road, Room 4200, College Park, MD 20740 or sent by e-mail to foia@nara.gov. Depending on how your appeal is filed, please be sure to cite case number **RD 40132** and "Freedom of Information Act Appeal" on either the envelope or in the subject line of the e-mail.

If you are interested in having NARA mail you copies of 100-HQ-344922, 100-CG-1816, or any other file released in full and listed in our May 5, 2015, correspondence to you, please contact me at mark.murphy@nara.gov or at (301) 837-1999, and specify the files you wish to have listed in our price quote. I will e-mail you the official quote. NARA charges \$0.80 per page so the estimated cost of the two files listed in this letter would be \$352.00. If you also include the released files listed in our May 5, 2015, correspondence, your estimated cost would be \$498.40. The price is the same whether you choose to receive paper copies or an electronic copy on CD, and NARA does not charge extra for shipping and handling as all costs are included in the quote.

If you would like to view paper copies of these files for free in our research room at our facility in College Park, Maryland, please contact me at least a week in advance of your arrival so reference copies can be created of the redacted records and brought to our holding area along with original files that have been released in full. If you bring a laptop with a CD-ROM drive during your visit, electronic copies of only the redacted files can be provided to you on CD to upload free of charge. You would still be responsible for making reproductions from the files that are released in full, but the cost is \$0.25 per page, which is a significant reduction compared to the cost of having us ship you copies. If you do not receive an acknowledgement within 48 hours of sending your notification of arrival, please contact our FOIA office at (301) 837-3190 or e-mail us at specialaccess_foia@nara.gov with your information.
