## 'CODDLING' ARABS CHARGED TO U. S.

### Way to Peace Is to Bolster Economy, Not Supply Arms, Rabbi Miller Tells Zionists

Rabbi Irving Miller, president of the Zionist Organization of America, sharply criticized last night the State Department's policy of "coddling the Arabs under the slogan of impartiality."

He held that any shipment of arms to the Arab states would not be used by them to thwart any Communist aggression in the Middle East.

One thousand delegates from over the country heard his address at the opening of the five-day, fifty-seventh annual convention of the organization in the Waldorf-Astoria Hotel.

The convention will discuss and act upon such problems as the relationship of the American Jewish community with Israel, United States policy toward Israel and the Middle East, and the formulation of plans for greater participation by American Zionists in the economic upbuilding of Israel.

In his report, Rabbi Miller said that the State Department's policy of "appeasement" toward the Arabs had "only served to encourage the Arab politicians to believe that they can continue and even intensify their hostility against Israel with impunity."

#### Dealing With the Arabs

Maintaining that the Arab states "would never take up arms in defense of Western democracy," the rabbi cited "blunders" made by the United States in supporting "a strong man" or "a military clique" that seized power in the Arab lands.

"It should now be clear that this is not the way to win real friendship for America and the democratic way of life in the Middle East," he said.

"We will not strengthen our interests in that part of the world by building our positions on peshas and politicians who are making the most of their brief taste of power and who seek to deflect public attention from their failures and shortcomings by violent attacks against Israel.

"The only way to win genuine friendship for the West and the Western way of life among the Arab peoples is to raise their standards of living and health, strengthen their economies and introduce democratic ideas in their backward societies."

Rabbi Miller emphasized that American Zionists "time and again have fought to uphold America's true policies and real interests in the Middle East, not only for the Jewish people but for the good name of America and the future of democracy."

#### Tribute Paid to Dr. Herzl

The opening session was dedicated to the fiftieth anniversary of the death of Dr. Theodor Herzl, founder of the world Zionist movement. Louis Lipsky, chairman of the American Zionist Committee for Public Affairs, paid tribute to Dr. Herzl's Zionist ideals and principles.

Dr. Harris J. Levine, chairman of the convention committee, called for closer cooperation by the Zionist groups in support of Israel's security and welfare.

In a message to Rabbi Miller, read at the session, President Eisenhower declared that the United States was "striving ceaselessly to help solve the pressing political and economic problems" of the Near East and that this entailed the development of "peaceful relations among the people who live there."

A message from Prime Minister Moshe Sharett said that his nation, "in its present ordeals and grave trials still ahead, continues to draw encouragement and sustenance from the great reservoir, devotion and constructive capacity inherent in American Jewry."

Other messages were received from Walter P. Reuther, president of the Congress of Industrial Organizations, and George Meany, president of the American Federation of Labor.

SUBJECT: CONTROVERSY ON ZIONISM IN A CLASS  
AT THE GEORGE WASHINGTON UNIVERSITY

At the present time, I am enrolled in a class at The George Washington University on Foreign Relations of the Middle East which is taught Tuesday and Thursday evenings by a Professor Spenser. The last two or three lectures have been devoted to Israel, with last night's discussion centering on the development of Zionism, the nationalistic, political theory, as contrasted with Judiasm, the religion. The professor has been quite objective throughout the course, quoting mostly from original correspondence of Middle Eastern Leaders, and from books by both Arab and Zionist authors. He has laboriously and repeatedly articulated the differences between Judiasm and Zionism, and could not, by an impartial observer, possibly be labeled anti-Semitic as he has the highest regard for the Jewish religion. By his educational background, his travels throughout the Middle East, and his rational, un-emotional approach to the subject, he is apparently well equipped mentally and emotionally to teach a class that numbers among its members both Arabs and Zionists.

Last night's class was particularly heated. The professor was reading from Lillienthal's "What Price Israel?" and from "Violent Truce" by E. H. Hutchinson, who was assigned to the UN Truce Supervision Organization from 1951 to 1952 when he joined the Israel-Jordan Mixed Armistice Commission. Lillienthal, who is Jewish, points out in his book the disservice done to Judiasm by Zionists in that the Zionists demand allegiance to Israel first. Hutchinson terms Zionism nationalistic aggression. One boy in the class, who proclaimed himself a Zionist, kept denying the charges against Zionism angrily and proclaimed the above-mentioned observations to be lies. The purpose of this memo lies in the statement made by another man in the class (who from what was said, was also probably Jewish). This second man said that while in the Marines, some of his Jewish friends related stories of Jews who have been asked by Zionists to divulge confidential and secret information. These Zionists put pressure on Jews, the second boy related, by telling them that their first allegiance is to Israel. He did not imply that any of his Jewish friends had turned over any information to these Zionists. This account infuriated the previously mentioned Zionist, who slammed his book on his desk, and walked out of the class. Later in the period it was reported that during the 1948 Israeli-Arab war that the Israelis had an excellent intelligence network, activated in a great many incidences by Zionists putting pressure on Jews in governments throughout the world.

RECOMMENDATIONS: None. Memo written with a thought to possible source of security leaks.

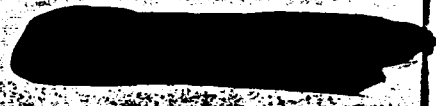

I listened to your discourse with Dean Pike, analyzing our rights, under articles of the Constitution. It was very interesting, as well as an important subject.

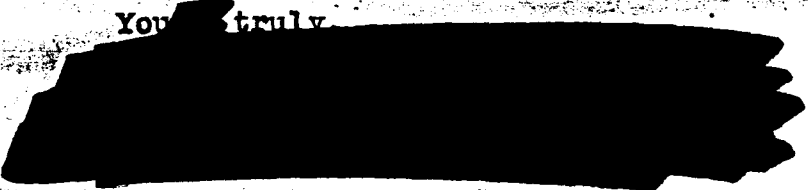
Herewith copy of letter, dated, November 9, 1956, to The Hon. Henry Cabot Lodge, Jr., Chief Delegate to the United Nations.

The following is in answer to the paid advertisements appearing in the New York newspapers under the caption "Suddenly the Middle East Explodes, WHY?"

In November 1916, The World Zionist Organization, at London, England, submitted a proposition along the following lines to Great Britain. The World Zionist Organization proposed that that organization use its influence amongst the World Jewry to bring the United States of America into World War 1 on the side of the Allies, provided that Great Britain in exchange for this service would set aside the territory known as Palestine, then held under a joint trusteeship by Great Britain and France, and to permit the establishment of the State of Israel in that trusteeship held territory. In November 1917, the White Paper called the Balfour Agreement was promulgated, France having agreed to the terms of the proposition. We have no literature available on the subject; however, Chapter 19 of "Masters of Deceit" is directly on the point and discusses the Soviet suppression of Zionism and the problem this creates for the Communist Party, USA, to avoid direct attacks upon Zionism which would thus alienate a large section of Jewish people who favor Zionism. It is believed a referral to this chapter will adequately answer correspondent's inquiry.

This advertisement was sponsored by the Louis D. Brandeis - Zionist District, Zionist Organization of America, Jacques Torczyner, President, 1529 16th Street, Washington, D. C. It appears from the advertisement that there exists a possible obligation on the part of the subject to register under the Foreign Agents Registration Act.

The advertisement contains a condemnation of the Soviet Peace Plan for the Middle East and ends with a request for money, with checks made payable to the Zionist Organization of America.

This Division would like to receive any information that you might have available on the subject. In addition, this Division would appreciate any information that can be developed as to the subject's activities within the United States and whether the subject is receiving funds from any foreign principal, including the Government of Israel. In this regard, this Division has no objection to your Bureau interviewing anyone else connected with the subject.
