"i. NUMEC official recommending visit approval: Z. M. Shapiro

"Please advise me of your approval action. Thank you very much for your cooperation."

On October 7, 1968, Clem Palazzolo, supra, made available a copy of a letter dated September 27, 1968, from [redacted] supra, to Harry R. Walsh, supra, which read as follows:

"Dear Mr. Walsh:

"Reference your telephone call concerning the September 10 visit of Messrs. Hermoni, Bendor, Eitan and Biegun, Israeli citizens. Please be advised of the following.

"The above mentioned gentlemen met with Dr. Shapiro, [redacted] and [redacted] with the exception of Dr. Shapiro, all of the NUMEC personnel are in our Energy Conversion Department and are thermoelectric generator specialists.

"Discussion with the Israeli nationals concerned the possibility of developing plutonium fueled thermo-electric generator systems in the 5 and 50 milliwatt power level. Specifically, they were interested in 10 generators in the 5 milliwatt range. Each of which would be fueled with about 2 grams of plutonium. The 50 milliwatt generator is considered a remote possibility, but would use approximately 20 grams of plutonium. The generators are of the terrestrial type.

"We are proceeding to make a proposal to these gentlemen for this work using, of course, only unclassified information which is already in the public domain. It is also our understanding that these same gentlemen have visited several of the major nuclear organizations in the United States to develop proposals from them on these items.

"I trust this satisfies your needs."

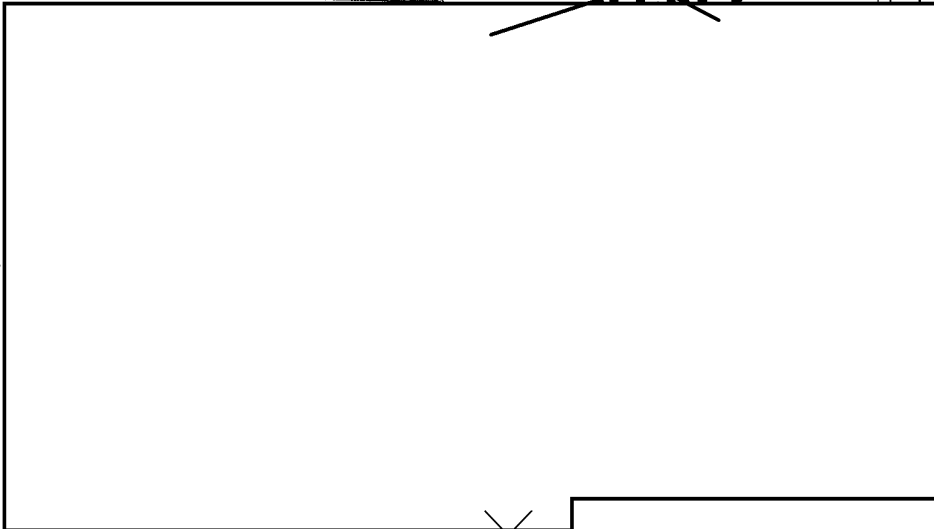

furnished reliable information in the past, advised that subject contemplates visiting Israel during the latter part of November, 1968, for a period of approximately two weeks. Source said he was unable at this time to explain the purpose of subject's visit, but was of the opinion subject owned property in Israel. Source said that he based this opinion on a comment made by subject's sister, Zipporah Schefrin. Source could not elaborate further on this matter.] (S)

(U) Source advised that he recently ascertained that Zipporah Schefrin, who is believed residing with her husband, Dr. Alex Schefrin, at [redacted] New Jersey, was planning to leave New York City on October 10, 1968, for Israel accompanied by a group of approximately 63 individuals. (S)

(U) ~~(S)~~ ~~(S)~~ [On October 6, 1968,] a third source, [redacted] who has furnished reliable information in the past, reported that subject recently requested his sister, Zipporah Schefrin, to contact [redacted] during her October, 1968, visit to Tel Aviv, Israel, for the purpose of extending his greetings to [redacted]. According to source, subject described [redacted] as being a very interesting and extraordinary person. Source said Zipporah was further requested to be sure to contact one Dr. Ernst Lubin (phonetic) who was reportedly born in Argentina and a very interesting individual. Source revealed that in addition to the aforementioned names, subject furnished Zipporah a list of names and telephone [redacted] (S)
