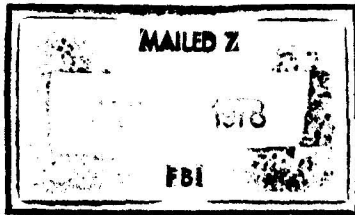

Result of examination:

Q1 and Qc2 were searched in the appropriate sections of the Anonymous Letter File with negative results. Copies will be added thereto.

It was determined that the stamp affixed to the Q1 envelope originated from a sheet of stamps.

The typewriting on Q1 and Qc2 most closely resembles Laboratory standards for a pica style of type used on L. C. Smith brand typewriters.

No watermarks, indented writing or other characteristics of significance were noted during the examination of Q1 and Qc2 which would aid in determining their immediate source.

Q1 and Qc2 will be returned with the results of the latent fingerprint examination. Appropriate photographs are retained.

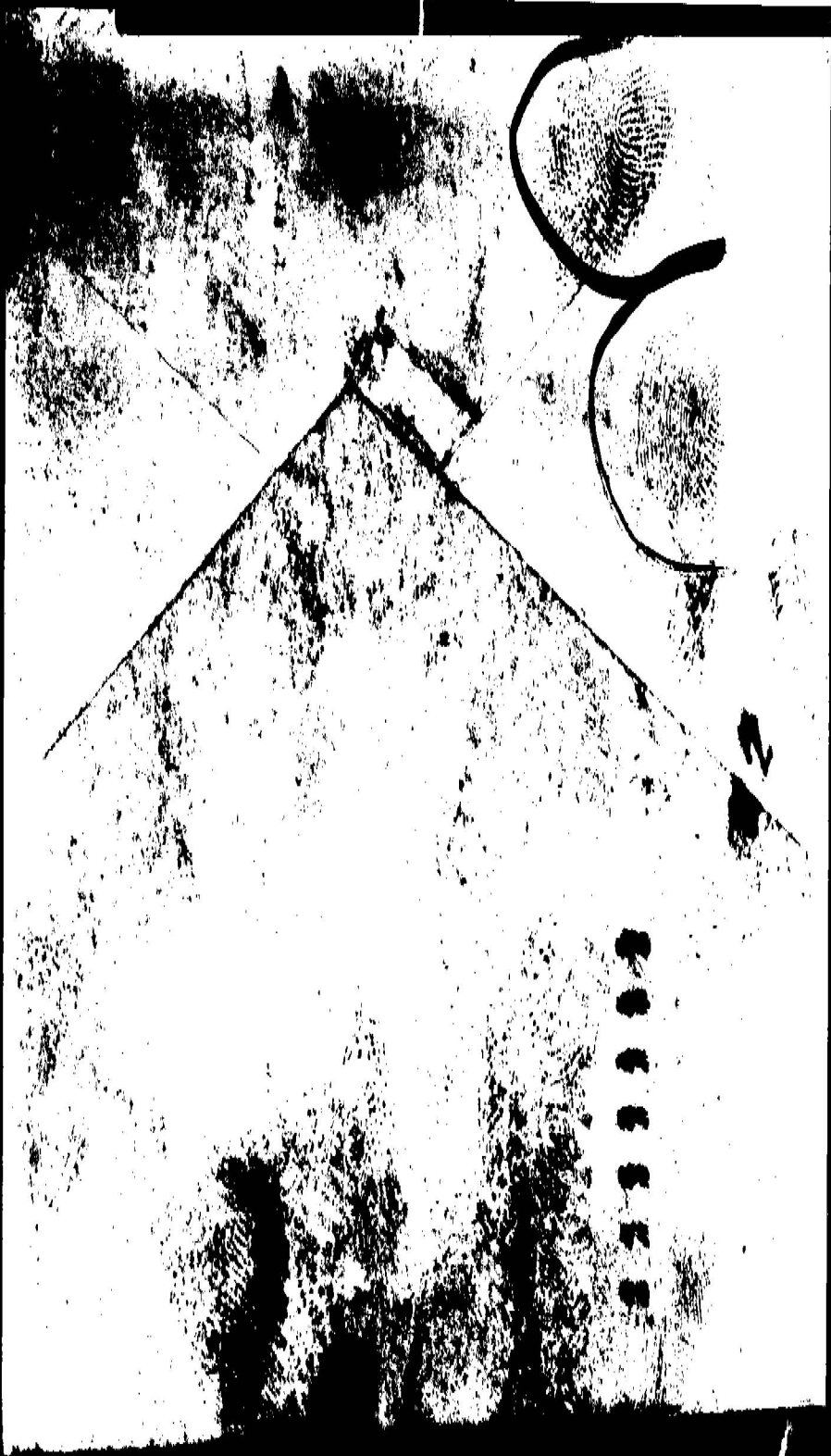

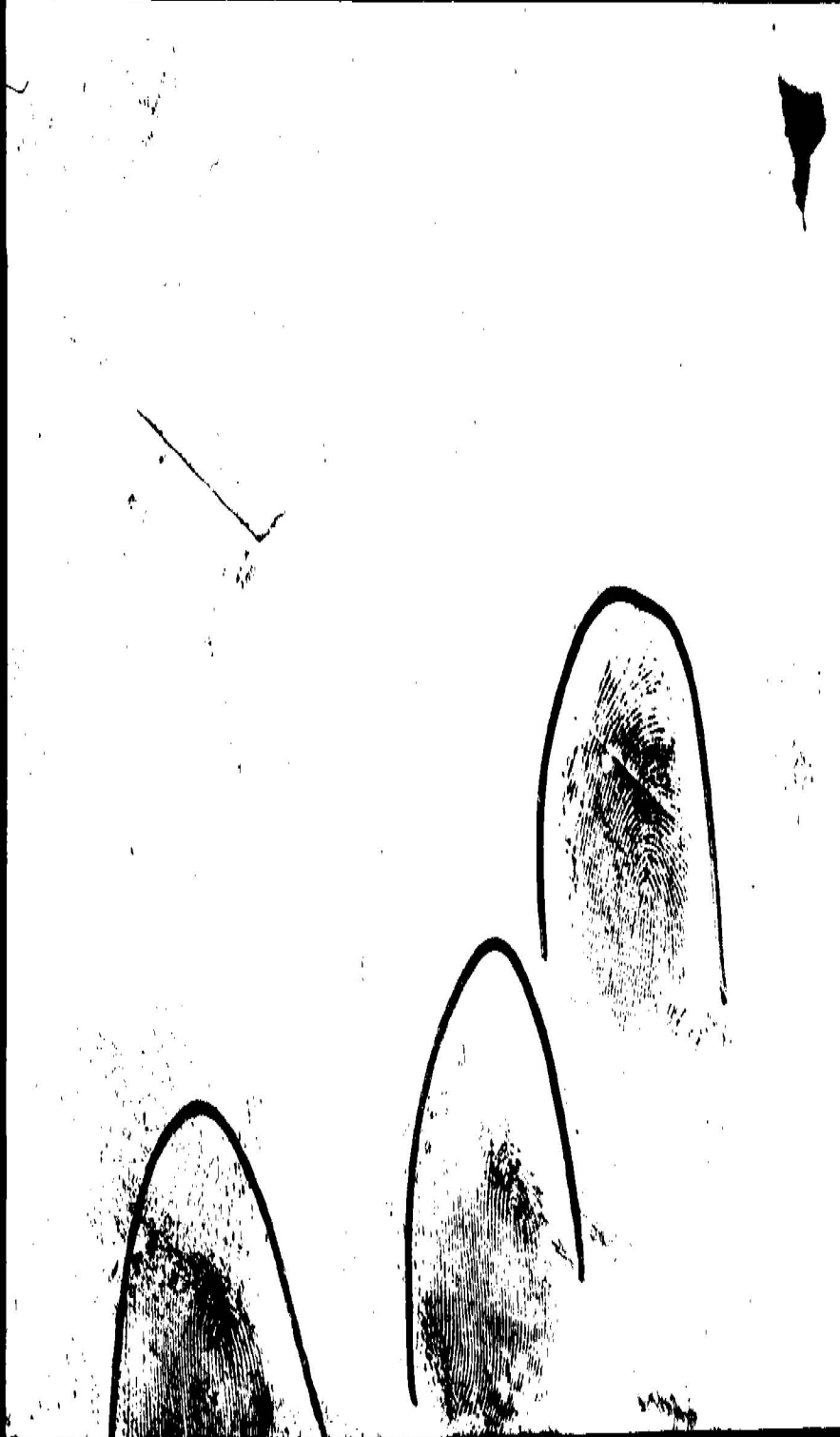

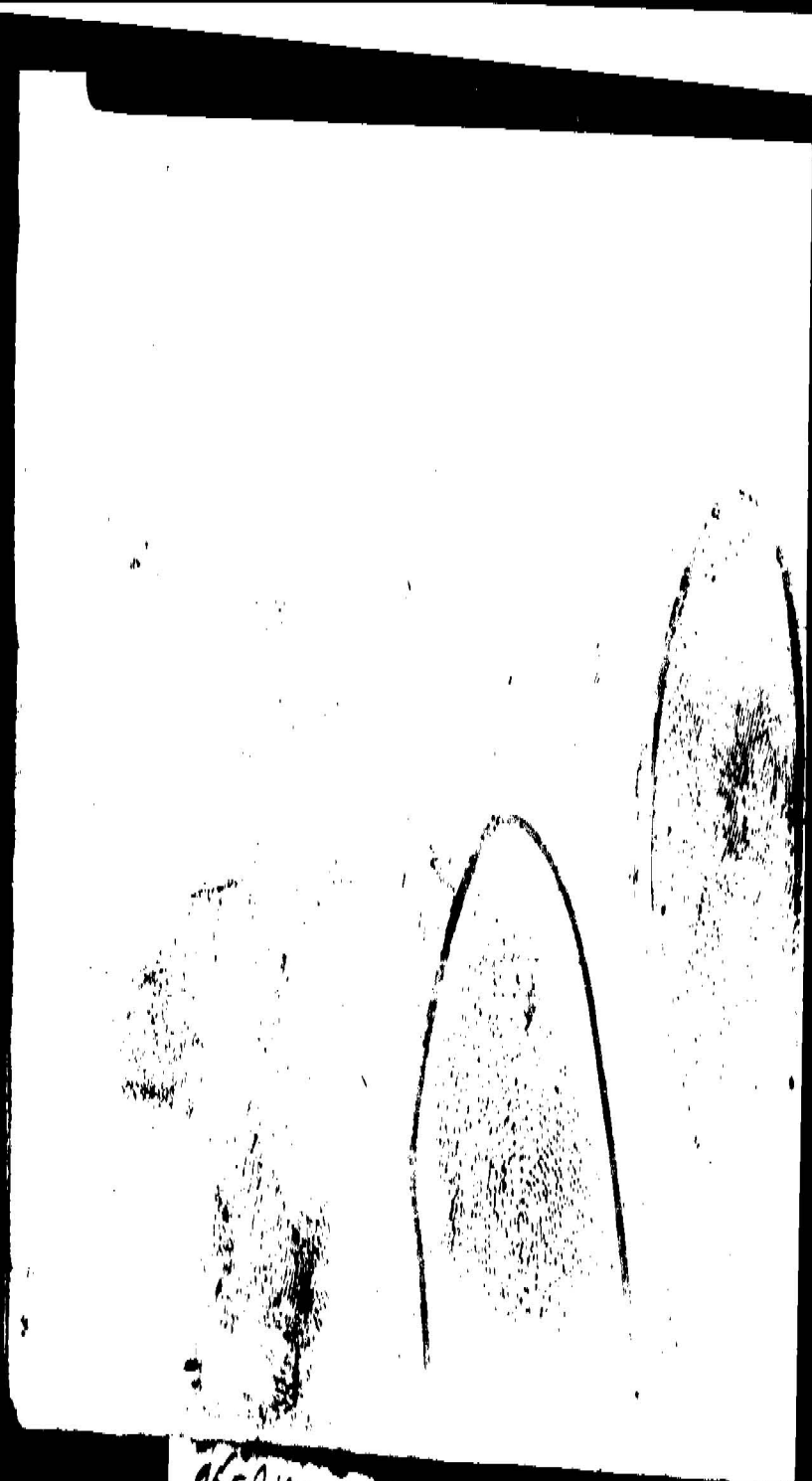
